

## Dual Credit

A new application for Dual Credit enrollment must be submitted each semester. The program is available to high school junior and senior level students subject to the following provisions:

1. The student must have the approval of his/her parent/guardian and high school principal/counselor.
2. The student must complete and submit a Freshmen Admissions Application to A&M-Texarkana and a residency questionnaire by logging on to [www.applytexas.org](http://www.applytexas.org).
3. The student must document that they have satisfied the Texas Success Initiative (TSI) requirements. If the student has not satisfied TSI, the student is not eligible for enrollment with A&M-Texarkana.
4. The student must submit an up-to-date official transcript from their high school.
5. An official high school transcript showing the graduation date should be sent to A&M-Texarkana as soon as it is available. Official university transcripts will be available once a final high school transcript is received. If an A&M-Texarkana transcript is required prior to graduation, the student should contact the Admissions Office. The student's signature below authorizes A&M-Texarkana to release grades to the high school counselor at the end of each semester and the high school to release official transcripts to A&M-Texarkana as needed.
6. The student must maintain at least a 2.0 cumulative grade point average at A&M-Texarkana to continue in the dual credit program.
7. If the student is enrolled with another institution while enrolled in the dual credit program at A&M-Texarkana, the student must request official final transcripts be sent to A&M-Texarkana by the issuing institution(s).
8. The student will register for classes and pay all regular tuition and fees during the regular registration period and as an A&M-Texarkana student will be responsible for observing all University regulations.

State law requires that you will be informed of the following: 1) you are entitled to request to be informed about the information about yourself collected by use of the form (with a few exceptions as provided by law); 2) you are entitled to receive and review that information; and 3) you are entitled to have the information corrected at no charge to you.
