- C: **Forms needed:** Requests for data access **must** be accompanied by the appropriate supporting information:
 - 1 - FAMIS Statement of Responsibility (separate form)
 - 2 - Documentation of Official training after it is conducted.
- D: **Routing:** Requests for data access will be routed to the VPFA office for approval by the data owner. Supervisors will be informed immediately if there are questions or concerns in order to obtain further supporting documentation as necessary.
- E: **User access** will be reviewed annually prior to September 1 by the user's supervisor and the appropriate data owner to determine the need for continuation and/or revision of access during the next fiscal year. A Security Access Renewal Form (or electronic equivalent) must be signed and submitted to the Information Technology office every year in order to maintain access to FAMIS.

PART IV: MENTOR TRAINING

- A. Access to FAMIS/Canopy is granted to the above employee if all forms and signatures are complete and approval of the data owner is obtained. All FAMIS security policies will be reviewed with the new user.
The employee must attend the next scheduled official training session or access will be revoked.
