## Instructions

- 1. Students must submit the Dual Credit/Concurrent Enrollment Application, an official high school transcript, and ACT or SAT test scores.
- 2. This form must be signed by the student, parent or guardian, and high school principal or counselor.
- 3. Eligibility is limited to high school junior (11th grade) and/or high school senior (12th grade) students.
- 4. Students must be exempt based on ACT, SAT, TAKS, PSAT/NMSQT, PLAN, and/or End of Course (STAAR EOC) scores to satisfy the Texas Success Initiative (TSI) requirements or must pass the appropriate sections of the TSI Assessment to enroll in courses. For a full list of exemptions please click here.
- 5. If the student has not satisfied TSI, the student is not eligible for enrollment with A&M-Texarkana. Students may not enroll in remediation courses as dual credit/concurrent students.
- 6. Permission is limited to the term indicated on the application and must be separately granted for continued enrollment prior to high school graduation.
- 7. The student must maintain at least a 2.0 cumulative grade point average at A&M-Texarkana to continue in the concurrent enrollment program.
- 8. If the student is enrolled with another institution while enrolled in the concurrent enrollment program at A&M-Texarkana, the student must request official final transcripts be sent to A&M-Texarkana by the issuing institution(s).
- 9. The student will register for classes and pay all regular tuition and fees during the regular registration period and as an A&M-Texarkana student will be responsible for observing all University regulations.
