COURSE DESCRIPTION:

Course Description: This course introduces undergraduate students to health care ethics. It includes the philosophical underpinnings of health care ethics, examples of health care dilemmas, and examples of legal documents that are important during health care delivery. Some of the topics discussed include, but are not limited to, euthanasia (active and passive), hospice, abortion, patient rights, the refusal of chemotherapy, and medical use of marijuana for adjunctive cancer pain treatment.

2. Distinguish among the various ethical principles and legal aspects that impinge upon healthcare delivery;
3. Critique various legal precedents that impact ethical issues confronted by healthcare professionals in the delivery of care;
4. Analyze the various ethical frameworks as they apply to healthcare;
5. Critique various ethical systems

Criteria for Written Assignments:

All written assignments must be prepared on a computer using 12-point font and in correct APA format as indicated in the 2010 APA Manual. All written assignments must have a title page. All papers will be graded according to the specific criteria and rubric given for each assignment. Due dates for each assignment are indicated on the class schedule.

All papers must be submitted in Microsoft Word format or pdf.

Book Review/Critique:

This assignment is a 5 – 7 page paper (exclusive of title page and references) in which you review and critique one of the books listed below:

4. Metaxas, E. (2010). Bonhoeffer. Dallas: Thomas Nelson. (Note: This book is a biography; however, you will be able to discern Bonhoeffer's ethical stance and therefore will be able to write your review/critique according to the criteria listed below for this assignment.) (See Rubric in Bb)

6. Fremgen, B.F. (2012). *Medical law and ethics* (4th ed.) New York: Pearson.

In this paper, you must:

1. Summarize and give a synopsis of the book;
2. Discuss how the author views the nature of ethics as a discipline; (N.B. if you review Metaxas' book, give Bonhoeffer's view of the nature of ethics)
3. Critique the author's viewpoint on ethics; (N.B. same comment as above in #2)
4. Compare the author's viewpoint on ethics with your viewpoint; (N.B. same comment as #2 above)
5. Identify how reading and reviewing this book has enhanced your understanding of ethics as a discipline that has relevance to healthcare.

Journal Article Critiques:

These two assignments are 2-3 page papers critiquing journal articles discussing a particular aspect of ethical principles that apply to healthcare and an ethical issue in healthcare. For the first critique, select an article from one of the journals listed in "Information" that discusses the issue of justice and the **allocation of health resources**. For the second article critique, select an article from one of the journals listed in "Information" that discusses a **specific issue in healthcare** such as abortion, euthanasia, organ donation, etc. use the following criteria to write your paper: (See Rubric in Bb)

1. Discuss the nature of the issue you are discussing in the paper;
2. Summarize the article in terms of the author(s)' main points;
3. State your reasons for agreeing or disagreeing with the author(s)' main premise (support your reasons from the texts or other references);

STUDENT PARTICIPATION

- **Participation Policy:**

The student is expected to participate in assigned online discussions by making an initial posting with responses to other classmates, as assigned. You will complete a family project that includes a teaching product, write a scholarly paper, and create an on-line presentation. You may use your own family, but be sure to keep all information confidential. All assignments and discussions must be turned in by 2400 on the due date to receive the most points. They may also be turned in early.
